As some of you may have noticed, we now have a brand new roundabout at the SR 61/ Dallas Highway and Punkintown intersection!

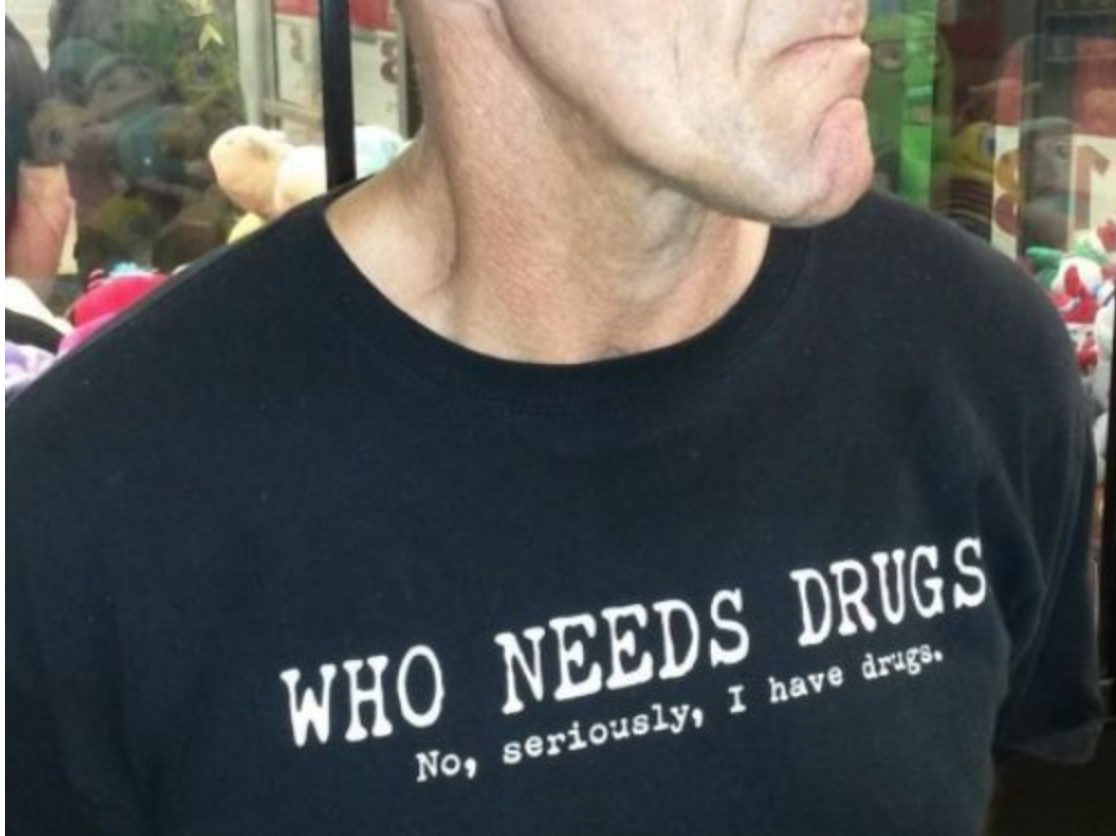
