Florida man claims he only drank at stoplights, and not while driving



In Vero Beach, Fl, police were called out one night to a local McDonald's because of a car repeatedly bumping the car in front of it in the drive-through. The driver, Earle Stevens, 69, was sitting in his car with a bottle of Jim Beam on the passenger seat when police arrived. The police immediately smelled alcohol on his breath and asked him if he was drinking and driving.

Earle insisted that he was NOT drinking and driving, that he was only drinking when he was stopped at a red light or stop sign, never when his car was moving. When they asked Mr. Stevens to get out of the car, he could not stand up straight as he was swaying back and forth from being so intoxicated. He blew a .153 on a breathalyzer test, nearly twice the legal limit of 0.08 in Florida, and he was arrested. The Judge in his case disagreed with his defense and charged him with DUI, which no one except Mr. Stevens was surprised about.
