DUI Blood Tests Roadside



Soon, Trained Officers Will Be Able to Draw Blood From DUI Suspects in the State of Georgia

Drunk drivers, beware. In the State of Georgia, trained officers will soon be able to draw blood from drunk drivers, impaired drivers, or DUI suspects. And it can happen on the spot of the actual DUI arrests. Over a dozen other states already have very similar laws to this one. By the end of 2021, the Governor's Office of Highway Safety expects to have close to 100 trained officers certified in this new program.

People in the State of Georgia law enforcement community believe that this new program of actually drawing blood from impaired or suspected DUI drivers roadside will provide critical evidence for prosecuting DUI cases. In addition to alcohol, the test can also check for illegal and prescription drugs in the bloodstream.

The officers in this new program will become certified phlebotomists. If you don't know what a phlebotomist is, basically, they are trained medical professionals who take blood samples from patients. Additionally, the law enforcement community is very excited about this possibility because these blood tests will be more detailed than typical breathalizers and are historically much more accurate too.

A judge must sign a warrant, or the DUI suspect must consent for the blood draw to occur. But once a search warrant has been issued for a suspect's blood, the driver is required to give the blood sample.

On October 4, 2021, the first group of officers will begin training to learn this new skill. State troopers, HEAT officials, and Georgia State Patrol Nighthawk officers will be among the first to receive training, sending in teams from all over the state to learn this new skill.

DUI is a very serious charge and can lead to massively expensive fines, loss of driving privileges, and even jail time. Easy Pumpkin Dip



Yes, it's that time of the year again. And nothing seems to suggest fall like the complete and utter pumpkin "spiceification" of everything you like to eat (and maybe a lot of things you don't want to). Either way, whether you love it or hate it, it's September, and it's going to happen.

With that being said, this excellent dip recipe is a perfect example of that single fact. People love dips. People love pumpkin spice. So why not combine those two loves and make a sweetly spiced pumpkin dip? You could even use this as a spread on your favorite slices of bread. See the easy-to-make recipe below. You're welcome, by the way, LOL!

Easy Pumpkin Dip

Prep Time: 5 minutes

Served with/on pretzels, apple slices, cookies, gingersnaps, sliced pears, vanilla wafers, your favorite pieces of bread, you name it

Ingredients necessary:

- 1 eight oz package cream cheese (soften before using)
- 1 cup pure pumpkin. Do NOT use pumpkin pie filling
- 2 tbsp brown sugar
- 1 $\frac{3}{4}$ cups powdered sugar
- 1 $\frac{1}{2}$ tsp ground cinnamon
- 1 $\frac{1}{2}$ tsp pumpkin pie spice

Directions:

- Beat softened cream cheese in a big bowl until fluffy, about 2–3 minutes
- Add brown sugar and pumpkin to cream cheese and beat the mixture until it is well combined & creamy
- Next, add in the powdered sugar a little bit at a time to the mix and beat it until it is thoroughly combined
- Lastly, add remaining spices and beat until creamy
- When finished, transfer the dip mixture to an airtight container
- Store completed dip mixture in the refrigerator until ready to serve
- Serve with your favorite foods like – apples, nuts, cookies, pieces of bread, etc.
- Store leftover pumpkin dip in the refrigerator – if there is any :)
